# Minutes of a Meeting of Highnam Parish Council held in The Old School on Tuesday 12 March 2019

# 2. To coopt new Councillor

Mr Kevin Emmerson had declared an interest in joining the Parish Council; a resume had been previously circulated to all Councillors. It was proposed Cllr Coats, seconded Cllr Welch that Mr Emmerson be invited to join Council

6. To receive County Councillor's Report

Cllr Awford reported that £150m has been invested in Worcestershire Highways. Glos CC members have had their personal budgets increased by £5k, and some of his budget would be directed to Highnam. Various increases in spend were agreed in the Glos CC budget, including Rural Broadband

7. To receive District Councillor's Report

Cllr Davies offered apologies for his previous absences, and reported on his recent fall in the village, where he was quickly well supported by residents, who cared for him whilst waiting for the emergency services. He reported to the meeting that he would be standing down as District Councillor this year, when members of Council offered their thanks for his long service to Highnam as DC

8. To receive Clerks Report -

Clerk reported on a meeting with Glos Highways over issues in Highnam. The meeting was constructive and some actions were agreed; others were considered to be of lower priority. He reported on a complaint received that the construction vehicles working on Lassington Lane resurfacing had badly damaged the grass verge adjacent to Lassington Grove. He reported that Litter/Dog Poo bins at Lassington Reach will be provided when building work has been completed. He also read a letter from TBC responding to Council concerns over a TBC challenge related to Land Supply referred to in the Oakridge decision. The letter assured that the challenge was specific to Land Supply, and will not revisit the appeal decision. Some concern was expressed by Councillors who hope that this proves to be the case.
