Cllr Awford reported Gigaclear had agreed to arrange for their spoil removed from The Green; Reorganisation of responsibilities at GCC Has meant him taking on a role with Adult Social Care, where there will be tough choices to be made, with a need to look at smarter ways of working. Money has been set aside for road repairs in Highnam, and for some hedge cutting on Cycle Path. Environmental issues are also being looked at including Tidal Power.

Cllr Jill Smith had sent her apologies but Cllr Paul McLain reported that TBC are having to consider their housing land supply with a judge having decided that is amounted to only 4.33yrs. An application is being considered for 800 houses at Fiddington. TBC have received grant money to investigate a Garden Village at Ashchurch. There is no indication yet when the Judicial Review of TBC Housing Land Supply will be decided.
