# Items raised from last meeting

Public Forum – Members of the public may make representations, ask questions and give evidence at a meeting in respect of the business on the agenda by invitation of the chair. The Chairman welcomed the public and invited members to raise matters of interest.

- Concerns raised regarding ball games on a green in Farthing Croft, more recently golf balls which is causing a nuisance for neighbouring properties. This was raised previously and managed by Cllr M Welch and TBC.
- ACTION: Clerk to speak with TBC to understand what can be done.

- A question was asked "why, for the third month running that invoice's are not available on the HPC website?" Cllr Coats responded to advise the Clerk has been on annual leave and these will be posted in due course.
- Grass cutting question was posed why is the HPC paying for the grass at the end of Lassington Lane when this is owned and should be the responsibility of Gloucestershire County Council? Cllr Coats responded to advise this would be discussed under item 11 - to review approve contract for grass cutting.

- Auditors and costs for the container for the Scouts was mentioned at the meeting.
- Work has been completed for the Annual Accounting and submitted to KPG Littlejohn.
- I have spoken to the Scouts and they are waiting for cost for the container. The size is a 20ft container.
- The mowing schedule is detailed: large tractor mower is due on a 6/8 weekly basis for large areas like the playing field. The sit on mower and smaller mowers used to reach smaller areas will come 3/4 weekly. The Highnam Parish Council has employed a contractor to do the following: Lassington Reach entrance two triangle areas and the inside the playground. Due to Ubico not cutting the triangle area at the bottom of Maidenhall and following complaints last year and this we agreed for the contractor to cut.
- I have e-mailed Tewkesbury Borough with issues of the playground and I have been assured this was being dealt with following their own assessment.
- I will be changing the contact details on the Noticeboards.
- Following changes to the Environmental Working Group funding I am currently waiting for their annual costs so I can update the flow chart for payments. Once received I will then request Council to delegate authority to clerk to make payments.
