Highnam Parish Council Meeting

Gambier Parry Hall: Tuesday 11th October 2022 @ 19.30hrs

Present: Clirs C Coats, M Welch, V Tustin Smith, B Harding, R Keene, P Dyche, W Badham and W Nicol

In Attendance: 5 members of the public.

Public Forum – Members of the public may make representations, ask questions and give evidence at a meeting in respect of the business on the agenda by invitation of the chair. The Chairman welcomed the public and invited members to raise matters of interest.

- Yan Watkins, Chairman Highnam Community Centre Trust (HCCT) asked the council if there had been any progress or an update on the release of S106 money from Tewkesbury Borough (TBC). This was initially discussed at the May 2022 meeting. HCCT are concerned there will be penalty and delay charges implemented by the builder. Would TBC pay any penalty payments? This has been followed up and chased with TBC.
- HCCT Trustees, Yan Watkins (Chairman) and Bob Train (Treasurer) will be stepping down at the AGM in November. They will remain as trustees till Jan 2023. The original constitution states there should be 2 Highnam Parish Council trustees, 1 Highnam Players, 1 from the PCC and 1 Carpet Bowls. As all groups are in existence would Highnam Parish Council encourage them to become trustees and to attend the AGM 10th November?
- Speeding was raised, Chairman replied this will be discussed as an agenda item.
- Concerns was raised on the work being completed by Great Western Power. Various sites
 rubble has been left and grass areas not been restored. Resident mentioned they called the
 hotline, but no response. Action: A letter will be sent requesting a meeting with the
 contractors.
- An update has been published on the Parish Council website, without authority on the grass regime. The area in Maidenhall and Lassington Lane/B4215 has been adopted and owned by Gloucester County Council. Why is the council cutting grass twice a month and other areas less per month. Resident has paperwork to confirm this. Martin Clark from TBC have agreed to discuss any concerns on grass maintenance.
- Pollinating areas, pegging area have not been removed and not been mowed, why?
- The Environmental Working Group questionnaire. This is an agenda and will be discussed.
- White gates into the village were raised at a previous meeting. This was agreed could be a deterrent to speeding. Has the council had anymore thoughts? Following the success of the Parish Council applying for funding through the Community Speed Awareness project it was mentioned a grant is available for the gates which the council will be pursuing.

- TBC have been informed about a broken dog waste bin in the alley way near the school.
- A resident has complained about users of Highnam Football Club (HFC) blocking the bus stop opposite the entrance to Brimsome Meadow.. Even though FCH have added cones these are being moved by car owners to park.
- Anti-Social Behavior in Farthing Croft. I have raised this with Tewkesbury Borough Council. However, I have not received a response.
- Land owners have raised some issues regarding the stiles that have been adjusted.
 There are some reports of residents sustaining injury, the issue is landowners have not been asked permission for the work and initially liable if a member of the public were to be injured. I have some guidelines for the erection of styles therefore a discussion with the landowner should take place.
- We have received a cheque £168.94 from the former Highnam Table Tennis Club. The
 constitution insists any money outstanding will be donated to Highnam Parish Council
 when the club folds. Chairman asked Councillors for suggestions on how to spend the
 donated money.
- Contract and Licenses Are council in agreement to add these to the website? This will be added to the Finance, Governance and Audit Committee agenda.
- GAPTC has just sent out the second run of applications for funds for councils to apply on introducing additional Speed awareness measures.

11. Speed Awareness within the Village.

Back in May the council was successful in The Community Speed Awareness Fund for bin stickers, and a community speed watch camara. The camara captures speeding cars and could lead to a warning a letter being sent to vehicle owners with warnings of possible prosecution.
